ORDER DECLARING THE ORGANIZATION OF THE KANSAS CITY DOWNTOWN
STREETCAR TRANSPORTATION DEVELOPMENT DISTRICT

THIS MATTER IS BEFORE THE COURT following the vote of the “Qualified Voters” (as defined in the Missouri Transportation Development District Act, §§ 238.200 – 238.275, RSMo, as amended (the “Act”)) within the proposed Kansas City Downtown Streetcar Transportation Development District (the “District”), and the Court’s Order dated April 27, 2012, as amended (the “Formation Order”), wherein the Court certified the First Amended Petition for the Formation of a Transportation Development District and called a mail in election pursuant to § 238.216 of the Act.


In the Formation Order, the Court ordered the Court Administrator of the Circuit Court of Jackson County, Missouri (the “Court Administrator”) to submit by mail-in ballot to the Qualified Voters within the limits of the proposed District the question whether or not they will establish the District (the “Question”). The Court ordered the Court Administrator to conduct the election in accordance with the requirements and procedures set forth in its Formation Order. Thereafter, the Court certified a team of four (4) individuals to serve as “Election Judges,” with an equal number of Election Judges representing each of the two major political parties.

Pursuant to the Formation Order, the Court Administrator has transmitted all returned ballots to the Election Judges, and the Election Judges have transmitted the certified result to the Court, which shows that the Question PASSED by a vote of 31 in favor and 14 opposed.

NOW, THEREFORE, pursuant to § 238.216.6, RSMo, it is **ORDERED, JUDGED,**
and **DECREED** that:

- (1) The District is and has been properly, duly and lawfully organized, and the name of the District is The Kansas City Downtown Streetcar Transportation Development District;
- (2) The results of the election shall be entered upon the records of the Circuit Court of Jackson County. Also, a certified copy thereof shall be immediately filed by the Court Administrator with the county clerk of Jackson County, who shall cause the same to be spread upon the records of the county commission.
